**SUBJECT:** 2018 IBEW/NECA Employee Benefits Conference Registration

Attached to this memorandum is the registration form to attend the 2018 IBEW/NECA Employee Benefits Conference held at the Naples Beach Hotel and Golf Club in Naples Florida from January 25-26, 2018. The pre-conference workshop will take place on January 24, 2018.

The purpose of this conference is to provide interested parties a forum to review the administration of the reciprocal agreements, discuss issues of common interests related to benefit trust funds, and to meet informally with their counterparts. The conference agenda will be aimed at local benefit plan trustees, consultants, actuaries, attorneys, local union business managers, NECA chapter managers, and administrators. The primary goal of the conference is to improve, on both the local and national level, the working relationship between all parties and to assist them by addressing today's complex health and pension issues. The program will also focus on an open discussion of the reciprocal agreements and how they can be improved or expanded.

The conference will commence Thursday at 8:30 a.m. with a reception from 5:30 p.m. to 7:30 p.m., and will conclude Friday at noon. The pre-conference workshop will be held on Wednesday, January 24, 2018, with an open forum discussion on reciprocity at 1:30 p.m., followed by a fund administrator's meeting from 3:15 p.m. to 5:00 p.m. This meeting is for all fund administrators and assistants and provides an opportunity to discuss issues of interest unique to trust fund administration. Following the meeting will be a reception from 5:30 p.m. to 7:30 p.m. The dress code for all attendees during the conference will be business casual or above, depending on your preference.
